2. In partial modification of Public Notice No. 13/2021 dated 23.03.2021, the following in para 4 is inserted:-  
  
**4(a). In case of amalgamation/merger of Banks, the modified annexure A (attached with this PN) needs to be submitted by exporter of their current Bank & no separate NOC is required from the previous bank.**
